PREFACE

The purpose of this handbook is to coordinate the HYRA activities by having available, to each Member Yacht Club, in one source the latest data concerning HYRA personnel; the current rulings released by its Committees; the race schedules of HYRA and its Member Clubs; the requirements for entry in the HYRA State Championship and similar events of US SAILING; and other useful data of value to those participating in or charged with the conduct of HYRA-sponsored events.

The handbook may supplement, but will not supplant recognized official publications -- such as the US SAILING version of the Racing Rules of Sailing, its Decisions on Appeals, its Race Management Handbook, the Judging Guide, etc. -- which should be in the possession of each Delegate according to his personal responsibilities or interests.

Each Section is, in effect, the bulletin-board of a specific Officer or a Committee whose chairman must see that it is kept current and complete, yet concise. Editing in conformity with overall policy of the Executive Committee, and publication, is the responsibility of the Secretary.

<u>The Handbook must never be considered to be in "final" form.</u> Sections 1 through 4 must be kept current at all times. Likewise, Sections 5 through 9. Only Section 10 (Guidelines) might be continued from season to season, with the rare addition of an item of major importance. The Secretary, or the Committee concerned, should be informed promptly of any errors when discovered, preferably in writing.

Reissued sheets should indicate the revision date.

SECTION 3

HAWAII YACHT RACING ASSOCIATION CONSTITUTION AND BY-LAWS

CONSTITUTION

Article I - Name

A. The name of this Association shall be "Hawaii Yacht Racing Association".

Article II - Object

A. The object of the Association shall be to promote offshore yacht racing and class racing, in measurement classes and one-design classes and, in the promotion thereof, to

- 1. Promulgate and/or conduct each year a schedule of races for championships among individuals and meritorious classes (meritorious because of active competition therein, or because of the desirable type of yacht the class produces).
- 2. Sanction and/or conduct such races among Member-Clubs of the Association as will assume responsibility for holding the races so assigned to them and will agree that such races shall be open to any yacht qualifying in such a class whose owner is a member of a yacht club affiliated with this yacht racing association, which is a member of the United States Sailing Association (US SAILING); and that any such yacht which races therein shall have the right to appeal from the rulings of the Race Committee of such a Member-Club, to the Association.
- 3. Provide a committee to examine and decide appeals from the rulings of a race committee of any member club.
- 4. By a vote of the Delegates, arrange additional races with non-member organizations.

BY-LAWS

Article I - Membership

- A. The membership of the Association shall consist of:
 - 1. <u>Sailing Organizations</u> who are members of US SAILING and maintain a station or office in Hawaii, which shall have been elected Member-Clubs.
 - 2. <u>Individuals</u> who shall have been elected Individual Members. Individual Members shall have the privilege of attending all General Meetings of the Association and of addressing such meetings, but may not vote. They shall receive the publications of the Association. All HYRA individual members shall be members of US SAILING.
 - 3. <u>Corporations</u> who are members of US SAILING and maintain an office in Hawaii, which shall have been elected Corporate Members. Corporate Members shall have the privilege of attending all General meetings of the Association and of addressing such meetings, but may not vote. They shall receive the publications of the Association.
- B. A candidate for any classification of Membership shall apply in writing to the Secretary of the Association; but an application for yacht club or corporate membership may not be acted upon unless notice of such candidacy shall have been included in the notice of the meeting. The Secretary may elect any application to individual membership; but no such application shall be rejected except by the Executive Committee.

- C. A yacht club which is a candidate for membership shall file with its application:
 - 1. The various categories of membership available and the number of current members in each category.
 - 2. A list of the active fleets in that yacht club.

Article II - Representation of Member Clubs

A. <u>Each Member-Club</u> in good standing shall be entitled to be represented in meetings of the Association by Delegates to the number of one Delegate for each fifty, or major fraction thereof, voting members on its rolls; but a Member-Club shall not have more than twelve (12) Delegates.

B. A Delegate must be

- 1. An owner or part owner of a yacht enrolled in the Member-Club's fleet, or
- 2. Any other member of the Member-Club who is an active supporter of yacht racing.
- C. <u>At least fifteen (15) days before the Fall General Meeting</u> of the Association each Member-Club by its secretary shall certify to the Secretary of the Association a summary of the number of members designated by classes of membership.
- D. <u>Annually, by January 10</u>, each Member-Club shall submit its list of appointed Delegates with addresses and telephone numbers to the Association Secretary.

Article III - Election & Term of Officers

A. The Officers of the Association for the succeeding calendar year shall be determined annually by election at the Fall General Meeting. Thereafter, transfer of responsibility of any Officer to a duly elected successor may be made during the current year only if the incumbent Commodore deems it to serve the best interest of the Association. To fill any vacancy which may occur in an elective office, the Executive Committee may appoint any Delegate for the unexpired term.

Article IV - Officers and Executive Committee

- A. <u>The officers of the Association</u> shall be: Commodore, Vice- Commodore, Rear Commodore, Secretary and Treasurer. They shall become Delegates-at-large upon election to office.
- B. <u>The Commodore</u> shall preside at all meetings and shall have all such powers and duties as usually appertain to such office. The Vice-Commodore shall act in his absence. The Vice-Commodore and Rear Commodore shall have such powers and duties as usually appertain to those offices and as are assigned by the Commodore.
- C. <u>The Secretary</u> shall keep full and complete record of the proceedings of all meetings, send out all notices and perform such other duties as usually appertain to such office. The Secretary shall mail to each Delegate and to the Secretary of each Member-Club within ten days after each meeting of the Delegates or the Executive Committee a copy of the minutes of said meetings.
- D. <u>The Treasurer</u> shall collect and receive all moneys, keep a correct account thereof, and deposit same in the name of the Association in such bank as may be approved by the Association, and shall disburse same in payment of properly approved debts of the Association. At the Spring General Membership Meeting of the Association, the Treasurer shall submit a full report, in writing, of the financial condition of the Association which shall have been previously audited and approved by the Auditing Committee. The Executive Committee shall appoint the auditor. The financial year shall begin the first day in January. As soon as feasible, the Treasurer shall appoint the (1) Budget Committee Chair, (2) Audit Committee Chair, (3) Trophy Committee Chair and (4) Annual Awards Committee Chair.

- E. The Executive Committee shall consist of the Commodore, Vice-Commodore, Rear Commodore, the Secretary, the Treasurer and as Delegates-at-large, the two immediate Past Commodores of the Association, with power to take any necessary action on behalf of the Association in the furtherance of its purposes during intervals between meetings of the Association, to set dues and to include the appropriation of Association funds for such purposes at its discretion, provided that all actions of such Executive Committee be agenda for full report and discussion at the next special or regular meeting of the Association following such action by the Executive Committee, and provided further that the affirmative vote of any three members of the Executive Committee shall be sufficient to cause actions to be taken.
 - 1. Any Member-Club may object to any non-routine appropriation of funds by a written protest to the Secretary of the Association, and if so protested within ten days, such appropriation shall not remain authorized unless approved by a vote of the majority of the HYRA delegates.

Article V - Standing Committees

- A. <u>As soon as feasible, the Commodore</u> shall appoint the Nominating Committee and any other standing or temporary committee that may be required to properly conduct the business of the Association. He shall endeavor to avoid the appointment of more than one Delegate from a Club to any one Committee.
- B. <u>As soon as feasible, the Vice Commodore</u> shall appoint the (1) Racing Rules Committee, (2) Committee on Appeals, (3) Program Committee, (4) Safety Committee, (5) Offshore Committee, (6) One Design Committee and (7) Multi-Hull Committee.
- C. <u>As soon as feasible, the Rear Commodore</u> shall appoint the (1) US SAILING Delegate Area H Events Committee, (2) Single Handed Championship Committee, (3) State Championship Committee, (4) Hawaii Youth Sailing Association and (5) the US SAILING Training Coordinator.
- D. <u>As soon as feasible, the Treasurer</u> shall appoint the (1) Budget Committee (2) Audit Committee, (3) Trophy Committee and (4) Annual Awards Banquet Committee.
- F. <u>The Executive Committee</u> shall from time to time determine the makeup of the various Standing or Temporary Committees.

Article VI - Meetings

- A. <u>The Spring General Meeting</u> shall be held in February at a time and place which the Commodore shall designate, for the purpose of receiving reports of committees and concluding action on the various matters which may have been brought up for discussion prior to the meeting.
- B. <u>The Fall General Meeting</u> shall be held in November at a time and place which the Commodore shall designate for the same above purposes and for election of Officers.
- C. <u>The Commodore shall call such other</u> General or Executive Committee meetings as he may deem advisable, at such time and place as he shall designate; and upon written request of five Delegates, he shall call a meeting to be held within thirty (30) days after the filing of such request.
- D. <u>Any Delegate may attend</u> any Executive Committee meeting, and the Commodore may invite other persons to attend.
- E. Every Delegate must vote upon roll call, unless excused.
- F. <u>Substitute Delegates</u> for a particular meeting may be appointed by any Member-Club upon written notice signed by an elected officer thereof if filed prior to convening that meeting.

- G. <u>Eight Delegates</u> directly representing at least three Member- Clubs <u>shall constitute a quorum</u>. Substitute Delegates shall be counted for that purpose, but officers and other Delegates-at-Large shall not.
- H. <u>Robert's Rules of Order, Revised</u> shall be the parliamentary authority for conducting of all Association meetings.

Article VII - Notices

- A. Notices of every meeting of the Association shall be sent to:
 - 1. Each Delegate and
 - 2. To the secretary of each Member-Club, such notices to be mailed not less than five (5) days prior to such meeting.
- B. Notices of each general Meeting shall be sent to all other Members.

Article VIII - Dues

- A. Dues are payable in the amounts shown below whether billed or not:
 - 1. <u>Each Member-Club</u> shall pay to the Treasurer upon election, and on each first day of January thereafter, dues as follow: If entitled to one Delegate, fifty dollars; and for each additional Delegate, twenty dollars.
 - 2. <u>Each Individual Member</u> shall pay the Treasurer a minimum of ten dollars per annum; or pro rata thereof from date of election until the succeeding January lst.
 - 3. <u>Each Corporate Member</u> shall pay the Treasurer a minimum of \$100.00 per annum.
- B. A Member in arrears on March lst shall be suspended ipso facto. A Member in arrears on August lst shall, ipso facto, forfeit membership.

Article IX - Amendment and Suspension of Articles

- A. These articles of association may be amended by a two-thirds vote of the Delegates present at a meeting, if a draft of the amendment shall have been filed with the Secretary fifteen (15) days before the meeting and same set forth in the notice of the meeting.
- B. The articles of association cannot be suspended under any circumstances.

Article X - Suspension and Expulsion

A. Any Member-Club or Individual Member may be suspended or expelled for cause by a majority vote of all Delegates entitled to vote on Association questions; but no such action shall be taken until after the Member shall have been furnished with a written statement of the charges preferred against him and shall have been given at least one (1) week's notice of the time when, and place where the same will be considered by the Delegates; and every such Member shall have the right to appear and be heard in answer to the charges before final action shall be taken by the Delegates.

SECTION 6

COMMITTEES UNDER THE COMMODORE

A. NOMINATING COMMITTEE

The Nominating Committee shall consist of three Delegates. It shall report to the Secretary of the Association ten (10) days before the Fall General meeting it's nomination of currently or previously qualified Delegates for Commodore, Vice-Commodore, Rear Commodore, Secretary and Treasurer. This section shall not prevent the nomination of other consenting qualified Delegates being made at the Fall General Meeting.

B. PUBLICITY COMMITTEE

The Publicity Committee shall perform such tasks as may, from time to time, be set by the HYRA Executive Committee.

C. COMMUNITY RELATIONS COMMITTEE

The Community Relations Committee shall perform such tasks as may, from time to time, be set by the HYRA Executive Committee.

D. HISTORICAL COMMITTEE

(Not Defined by the Constitution or By-Laws)

1. The Evolution of HYRA

(Note: The authenticity of the first several paragraphs is subject to challenge and correction. We would appreciate constructive criticism and suggestions, so that this Section can be reissued with complete and accurate facts.)

It is not known just when the first attempts were made to organize the several boating clubs of old Hawaii in an "association" to promote their common interests. It is known that in 1890 the Hawaiian Yachting and Rowing Association was founded as the outcome of match racing in the late 1880s between two locally famous schooners backed by rival factions which included well known names such as Hatch, W.G. Irwin, W.M. Gifford, Judge Sanford B. Dole and Lorrin G. Thurston. The Association continued with decreasing activity until the last of those mentioned had passed away. Presumably, if it was in fact an "association" of clubs, its members might well have included during its existence the Royal Hawaiian Yacht Club, Healani Boat Club, Myrtle Boat Club and possibly the Outrigger Canoe Club.

In December of 1924, shortly after the formation of the original Pearl Harbor Yacht Club, Herb Dowsett had lunch at the New York Yacht Club with Donald H. Cowles and Clifford D. Mallory, who were discussing the proposed formation of a "North American Yacht Racing Union". Mallory, who was to become NAYRU's first president and from its inception in 1925 through 1935, urged Herb to seriously consider the formation of a YRA in Hawaii as an original member of NAYRU when it took shape. It is believed this is the reason that, to this day, the NAYRU Constitution, in its listing of the original Member Associations then existing there is included among other "...and Hawaiian Islands Districts." Presumably, those "districts" were left open for original membership names until actual associations could be formed within those districts. Unfortunately, Herb was not successful in organizing a local YRA on his return. Probably the time was not yet ripe.

Shortly after the formation of Waikiki Yacht Club early in 1944, a loosely-knit organization called Hawaii Yachting Association was formed to coordinate the activities and scheduling of the several clubs. The time just wasn't right and inter-club relationships had no need for an association, so it petered out in about five years with little accomplished.

In the spring of 1957, during a telephone conversation at New York, Fearon Moore happened to mention to Bob Bavier that he would be returning to the Islands to retire, in mid-summer. It seems that Bob had visited the Islands shortly before and, as the then- secretary of NAYRU, had been tremendously

impressed with the growing activity in yacht racing of all kinds out here. He urged Fearon to investigate the possibilities after he became acquainted with the local setup. The subject came up subsequently in rules correspondence with Bob and Herb Ware - both members of NAYRU Rules Committee.

During 1958 and 1959, Fearon made several approaches to officers of the local clubs - but, again, the time was not right. There still was no real need for a local YRA.

By 1965, however, the boating boom had really taken hold in Hawaii - particularly in the ocean-racing groups. At an Operations Committee meeting of KYC in April, Glenn Clark urged all skippers to join NAYRU as individual members; and sketched his ideas of the advantages of having a YRA of the Hawaiian Islands - stressing the opportunity for local skippers to participate, if qualified, in NAYRU Championships for men, women, juniors, single-handed, etc. - with all the local advantages of coordination of local inter-club events which were by then becoming quite commonplace.

Art Bivens, then KYC's Vice Commodore responsible for sailing activities, became very enthusiastic over the YRA idea and immediately started the spade work for its formation. The following year, as Commodore, his continued efforts in this direction bore fruit, as attested in the minutes of the Organization Meetings which follow in K-3 of this Section of the Handbook.

The increased interest in the yacht racing in Hawaii is perhaps illustrated by two NAYRU YEAR BOOKS available to us, showing the following organizations in Hawaii as Member Yacht Clubs of NAYRU directly supporting its purposes:

SECTION 7

COMMITTEES UNDER THE VICE COMMODORE

A. RACING RULES COMMITTEE -- (Decisions on Rules and Prescriptions)

The Racing Rules Committee shall consist of at least three (3) persons. The Chairman will be appointed by the Vice Commodore. Other members will be appointed by the Chairman. All members of the committee shall be US SAILING certified judges. It shall promulgate as Special or standing instructions those decisions of the several committees of the Association which are permissible modification of the International Sailing Federation Racing Rules of Sailing, to the end that the desired principles be fully expressed in concise understandable terms. When requested, it will assist in determining the adequacy of course description and of other items for sailing instructions for a sponsored or sanctioned event.

HYRA Prescriptions - For Sponsored and Sanctioned Races/Regattas

The Sailing Instructions for a regatta shall not repeat these Standing Instructions, but shall contain instead the following: "Rules: The race will be governed by the Racing Rules of Sailing; the prescriptions of US SAILING; the prescriptions of HYRA; (except as any of these are altered by the Sailing Instructions); and by these Sailing Instructions."

- A. RRS 42, PROPULSION. Except for late starters or emergencies, engines may not be used for propulsion between the Preparatory Signal and the Finish. A late starter must, after its Start Signal, execute a full 720° turn on the pre-course side of the starting line after shutting off its engine or dropping its tow before starting. Whenever an engine or tow is used for these situations, the facts shall be reported to the Race Committee within the time limit for filing of protests. This modifies RRS 42.1.
- B. RRS 77, IDENTIFICATION ON SAILS: HYRA prescribes that each boat shall comply with RRS 77 and Appendix G, except that for local racing, a boat with a US SAILING offshore number may carry only the last three or less significant digits.

- C. COURSE SAFETY. A boat that is racing shall not pass between vessels of a tow.
- D. SINGLE ENTRIES: An entered boat in an established class, appearing at the start alone in her class, shall be entitled to start at her scheduled time, unless the Race Committee instructs her to start with another class. In either case, she shall be deemed the winner in her class for that race if she completes one lap of a multi-lap course or completes the full course of a point-to-point race. This modifies RRS 28.1
- E. HYRA ECOLOGY RULE: Non-biodegradable matter shall not be thrown overboard from the time a boat leaves it's mooring until it returns thereto. Truly accidental incidents are excluded hereunder.

C. MASTER CALENDAR COMMITTEE

The Master Calendar Committee shall consist of one Delegate from each Member Club. It shall submit at the Fall General Meeting a proposed race schedule for the ensuing year which, with such modifications as the Delegates of the Fall General Meeting may make and approve, shall be adopted as the schedule of races for the next season. Thereafter, no changes in the program of races may be made unless approved by three members of the Executive Committee. Each Member Club shall receive by December 1st of each year a copy of the proposed race schedule for the ensuing year.

HYRA Recognized Offshore Fleets shall include all classes racing under US SAILING recognized offshore handicap rules including IOR, IMS, AmeriCap and PHRF.
- 2. The Offshore Committee shall assist the HYRA Recognized Offshore Fleets in administrative matters such as designation of a schedule of selected invitational races for season championship scoring and designation of class size or rating breaks for sub-classes that affect multiple classes and multiple clubs. The Offshore Committee shall then communicate decisions on these matters to the various race organizing authorities to insure that these decisions are respected.
- 3. Offshore Fleets may become HYRA Recognized Offshore Fleets by submitting copies of their Fleet Articles of Association or By-Laws and copies of their class rules to the HYRA Offshore Committee.

<u>HYRA GENERAL GUIDELINES</u> <u>COMMODORES – RC FOR SAIL & REGATTA CHAIRPERSONS</u> <u>TREASURERS – HYRA DELEGATES</u>

CLUB COMMODORES

A. Overview

- 1. Your first HYRA duty is to make sure that your incoming Secretary sends a list of current Club officers and a summary of the number of current members in each available category of membership to the HYRA Secretary as soon as possible at the beginning of the year.
- 2. Require that your RC for Sail appoint a Head Delegate to HYRA and as many other delegates as your Club is entitled to.
- 3. Following your term of office, you will be eligible for membership in the Blue Gavel Association. This is an international association of Past Commodores of Yacht Clubs. There is an active chapter of Blue Gavel in Hawaii. For further information, contact your Club's past Commodore.

B. Events that Commodores usually attend:

- 1. WYC/HYC Opening Day:
 - a. Parade: Commodores are Judges; invitations from WYC
 - b. Brunch: Following the parade, HYRA & Club Commodores, and other dignitaries, are guests of WYC.
- 2. KYC Opening Day:
 - a. Parade: Commodores are Judges; invitations from KYC.
 - b. Brunch: Following the parade, HYRA & Club Commodores, and other dignitaries, are guests of KYC.
- 3. Sea Fest: Location varies--plan to attend this important fund-raiser.
 - 4. Hawaii Commodores' Association: Meetings the second Tuesday of every month; each Commodore hosts one luncheon, usually at their Club or other convenient location.
- 5. TransPac Awards Banquet: Odd years, late July, usually at own expense.
- 6. End of Season HYRA Awards Banquet: Late November; own expense.
- 7. Installation of officers of various Clubs: May be an invited guest; however, be prepared to pay own expense.

C. Events that the Commodores should try to attend:

- 1. Make every effort to attend functions to which you are specifically invited. It's part of the job.
- 2. Special events as scheduled, such as parties, fund-raisers, etc.
- 3. As many HYRA events as time permits.
- 4. US SAILING ladder events in which members from your Club compete.

GUIDELINES FOR REAR COMMODORES FOR SAIL & REGATTA CHAIRPERSONS

- 1. Each HYRA Club has been requested to purchase a copy of the US SAILING Race Committee Handbook. It serves little purpose sitting on a shelf somewhere. Read it and make it available to all members of the race committee, so they are also familiar with its contents.
- 2. At least 90 days prior to an event, file an application for your regatta with the Boating & Ocean Recreation Division of the Department of Land and Natural Resources. Then *check* the local Notice to Mariners when it comes out, so it can be determined if there are any other marine events going on in the area of your regatta. If so, contact the sponsoring organization and try to coordinate starting times and areas and placement of marks, and ask that their participants be made aware of the dual events. Include such information at your skippers' meeting. Also check the Notice to Mariners to make sure there have been no changes in government aids to navigation that will affect your race course. Clubs have been known to list, as turning marks, buoys which have long since been removed or replaced. If you are not on the mailing list for the Notice to Mariners, call or write the local office of the Coast Guard and have your name added, and have it sent to your home address. There is no charge.
- 3. If the regatta is a major one, arrange for a patrol or safety boat which can carry adequate communication, so that in case of emergency, the committee boat will not have to leave station to perform rescue duties. Patrol boats can usually be arranged through the Club's Rear Commodore for Power or through the Coast Guard Auxiliary.
- 4. When a new RC or Regatta Chair makes up Race Notices and Sailing Instructions, it often becomes easy to copy the ones from the previous year, merely changing the dates. This is a dangerous situation, for there may have been major changes since the previous year, such as relocation of buoys, changes in rules, inactivity of old classes, and addition of new ones. Perform a complete review of the information contained in the Race Notices and Sailing Instructions to ensure that they are accurate. Make an effort to find out ahead of time that classes are planning to participate, so there will not be large gaps in the starting order.
- 5. In the Notice of Race and Sailing Instructions, include the names and phone numbers, home and work, of at least two persons who can be contacted if there are questions regarding the race. This can save a great deal of time and hassle at skippers' meetings, and has been found to settle countless minor problems well in advance.
- 6. Publish and distribute Notices of Race for invitational events via the HYRA website, HYRA publicity, and/or hard copy delivery to all member yacht clubs three weeks prior to the event. Put out Sailing Instructions no later than <u>one week</u> prior to the event, following the same distribution procedure as for notices of race. Set up the procedures at your Club for distribution of notices and instructions so that they are readily obtainable by all prospective participants. NOTE: Often Clubs have combined Notices of Race with Sailing Instructions. *This procedure is not recommended.* However, if it is done, such combined notices should be distributed no later than two weeks prior to an event.
- 7. For major events, make publicity available to news media and arrange for press boats as necessary. Consider appointing a publicity chairperson to handle these details. Also, have the Club Commodore send invitations to other Commodores and VIPs as appropriate.
- 8. Make sure that any changes or additions made at the skippers' meeting are written and duly posted. Copies must be available for each competitor.
- 9. Check entry forms for proper completion, and make sure appropriate information, such as the name of the skipper, sail number, type of boat, class and rating are transferred to the race committee's worksheets. Both trophy chairpersons and the press utilize these final worksheets. All of this information is needed at one point or another. If it is *all* transposed onto worksheets from the entry forms, there is little room for error the rest of the way down the line.

- 10. At the skippers' meeting, and later aboard the committee boat, avoid verbal instructions and/or interpretations of the sailing instructions or rules. To quote the US SAILING manual, "It is important that no conversation take place between the Race Committee and the contestants. Verbal advice from a committee member could constitute a change or interpretation of the Sailing Instructions, which, if misleading, or not conveyed to the rest of the fleet, might result in a protest". It could also relieve your committee members of consternation and abuse if you would make an announcement to this effect at the skippers' meeting, so contestants are aware of the reason for a committee's silence on the starting line. However, there is no objection to making general announcements over the radio such as when the race committee plans to start the second race or the reasons for a postponement, etc.
- 11. Make it clear in your sailing instructions what exact information is to be called to the committee boat at check-in, usually *class*, *name of boat*, *sail number*, *and skipper's name*. Some committees insist on complete reporting in, others do not. If you *do*, make sure this is clear to all contestants--and what the consequences are for improper reporting in. In small fleets where the race committee is familiar with all the boats, there should be no requirement for a formal check in procedure.
- 12. Post race results promptly and get copies to your publicity chairperson or the news media as soon as possible. If protests are pending, make such notation, but get the tentative results posted promptly.
- 13. Appoint Protest Committee members a week in advance and insure that they hold protest hearings as soon as possible.
- 14. The tone of the trophy presentation is set by the MC. If the awards are presented indifferently, expect the recipients and the audience to respond in a like manner.
- 15. The Race Notices for *all* races, and the results, may be sent to HYRA Publicity Chair for posting on the HYRA website.
- 16. Remember that yacht races are conducted for the *participants*, not for the convenience of the race committee. For instance, a good starting line is critical to a well-run regatta, as is a good weather leg. You should allow plenty of time for setting and re-setting marks as necessary until the optimum course is obtained.

It is well recognized that it can become boring, hot, and tiring during the long wait for boats to finish. But keep in mind that all of the participants have their boats going just as fast as they can to get to your finish line and you should give consideration to how hard *they* have worked to complete the race. Most race committees feel unappreciated...it's universal. Do not accept persons to work on your committee, or come along on your committee boat, who are unable to understand the time, effort, and patience it takes to complete the job *properly*.

GUIDELINES FOR CLUB TREASURERS

- 1. HYRA DUES: \$50.00 for the first delegate and \$20.00 for each additional delegate your Club is entitled to. Your Club is entitled to one delegate for every 50 regular (voting) members, or major fraction thereof. As soon as you know the number of regular members your Club has in January, you should calculate the number of delegates you are entitled to and send a check to the HYRA Treasurer for the appropriate amount.
- 2. US SAILING dues. Each HYRA member club is required to be a member of US SAILING. The US SAILING annual dues for HYRA member clubs are \$100.00. This fee should be mailed to US SAILING prior to the end of each calendar year. The address is:

3. ENTRY FEES. Participation in the US SAILING Regatta Liability Insurance program requires that participating clubs charge a differential entry fee for members of US SAILING.

GUIDELINES FOR HYRA DELEGATES

1. APPOINTMENT OF HYRA DELEGATES:

The HYRA Constitution requires that a list of each Club's membership be mailed to the HYRA Secretary no later than 15 days before the Fall General Membership Meeting, which is the first Monday in November. From this list, the number of Delegates to which each Club is entitled is determined, based on one Delegate for every fifty--or major fraction thereof--voting members. Then, by the following January 10th, each Club must submit its list of appointed Delegates with addresses and phone numbers to the HYRA Executive Secretary. The method of selection of the Delegates is up to the individual Club, but most are appointed by the incoming Commodore.

2. APPOINTMENT OF HEAD DELEGATES:

Each Club should designate one of their HYRA Delegates as the Head Delegate. This delegate may be either the RC for Sail or someone appointed by the Commodore. Each Club is invited to send the Head Delegate to attend the HYRA Executive Committee meetings.

3. DISSEMINATION OF HYRA INFORMATION:

Call upon your RC for Sail or Head Delegate to give a report on HYRA activities at your monthly Board meetings--which report should then be summarized in the meeting's minutes. (Copies of all HYRA Executive Committee Meeting minutes are sent to each member Clubs' Head Delegate.)

4. BRINGING MATTERS TO THE ATTENTION OF THE HYRA EXECUTIVE COMMITTEE:

- A. All correspondence addressed to HYRA will be discussed at the next HYRA Executive Committee meeting following its receipt. If a written reply is requested, it will be given.
- B. Matters of concern to a specific committee may be referred to that committee's chairperson, either verbally or in writing. For action to be taken, however, the matter must be carried back to the Executive Committee.
- C. Matters of concern may be brought to the attention of HYRA through any of a Club's appointed Delegates, who may pass it on to the Executive Committee or the General Membership, as requested. It must be remembered, however, there are only three General Membership meetings per year: February, June and November.

5. INDIVIDUAL MEMBERSHIPS IN HYRA:

Individual membership in HYRA is available at a fee of \$10.00. Individual members must also be members of US SAILING. Individual members may attend all General Membership meetings and may address such meetings, but may not vote. See the HYRA Constitution, Article III, for details.

- 3.20 Cooking Facilities
 - HYRA prescribes that for the purposes of local racing in Hawaii, 3.20 will not apply.
- 3.27 Navigation Lights (see 2.03.3) HYRA prescribes that for the purposes of local racing in Hawaii, emergency navigation lights may be provided by a portable dry cell battery pack temporarily mounted on the bow pulpit.
- 4.10 Radar reflector HYRA prescribes that for the purposes of local racing in Hawaii, radar reflectors are not required for Category 3 or Category 4 races.
- **4.23** Pyrotechnic signals HYRA prescribes that for the purposes of local racing in Hawaii, US Coast Guard approved pyrotechnic signals may be used in lieu of SOLAS-approved signals.
- 4.26 Storm & heavy weather sails
 - HYRA prescribes that for local racing in Hawaii, the requirements for storm and heavy weather sails will not apply to Category 4 races but will apply only to Category 3 races.
- **4.26.4 (g** HYRA prescribes to amend the mainsail reefing to reduce the luff by at lease 10%
